If you allow us to post your legal notification, you may begin destroying inactive patient records, that are dated prior to May 2003, as soon as May 15, 2010. In partnership with The Better Shredder, a reputable shredding service, we offer three economical shredding options - one-day drop-off event, one-time pick-up or discounted monthly services.

#### Join us for The Spring Cleaning, After Taxes Drop-off Day on a Saturday, May 15, 2010.

The Better Shredder Truck will set-up in the MDDS parking lot from 8 a.m. to noon. Each "banker-sized" box is \$7 to shred, payable on-site only by cash or check (payable to MDDF). 100% of the proceeds benefit the Foundation!
